



## Required Documentation for Certification of Federal Benefits

To have your enrollment certified with the VA, you will need to submit the following and then see the School Certifying Official on the day you register on campus before you leave.

- A copy of your Certificate of Eligibility – it is your awards letter from the VA. It shows your percentage coverage and remaining months of eligibility.
- The UM Request for Certification – this is the information to be submitted to the VA along with your enrollment. On the UM Veterans Affairs' web page or in the Registrar's Office.

## The Alabama GI Dependents' Scholarship

## Post 9/11 GI Bill (CH 33)

### **Have you applied for your benefits?**

After the Post 9/11 (CH 33) benefits are transferred to you or if you are using your own benefits, you must apply for them. If you have not already applied, follow this link and click on Apply for Benefits:

Once the VA processes your application, they will send you a Certificate of Eligibility – of which UM needs a copy.

## VA benefits and paying for on campus housing

*Just* a quick reminder regarding VA benefits and on campus housing. The VA will not pay any housing directly to the University regardless of which benefit you use. If you live on campus, the Cashier's Office offers a payment arrangement service that will allow you to pay for on campus housing monthly. If you receive a monthly stipend directly to you from the VA, you may use that to pay your housing on or off campus, but housing is your responsibility to pay.
