POLICIES AGREEMENT – COMMUTER/DAY CAMP

By registering for the Montevallo Music Camp, the participant and the parent(s)/guardian(s) agree to read and to abide by all University of Montevallo and Montevallo Music Camp (MMC) stipulations summarized below and described in detail in the *MMC Policies* document posted at www.montevallo.edu/mmc.

1. We have read and agree to abide by all MMC policies as described in the *MMC Policies* document posted at www.montevallo.edu/mmc.
2. We have read and agree to abide by the University of Montevallo fire and safety regulations as described in the *MMC Policies* document posted at www.montevallo.edu/mmc.
3. We understand that camp leadership retains the right to expel camp participants for violations of the University of Montevallo and MMC policies as described in the *MMC Policies* document, and that under such circumstances, no refunds, in whole or in part, will be issued.
4. We understand that any and all camp tuition/fee payments submitted are non-refundable, in whole or in part, at any time or for any reason.
5. We understand that it is our responsibility to secure travel/trip/camp cancellation insurance should the camp participant be unable to attend or departs MMC prematurely for any reason.
6. We grant permission for the camp participant to participate in all MMC activities, including but not limited to, outdoor field activities/games and swimming.
7. We release and discharge the University of Montevallo, MMC, and all university faculty, staff, counselors, students, guest faculty/staff, and other camp participants from liability should injury, damage, or loss be sustained to the camp participant or their belongings.
8. We authorize staff members of the University of Montevallo and MMC to provide or seek treatment for the camp participant in the event of a medical emergency and guarantee payment of any and all medical charges incurred. We understand that MMC staff will attempt to contact one or both parents/guardians before any emergency medical actions are taken, as able. We grant permission for the camp participant to be treated with over-the-counter medications, unless refused herein, for minor illnesses (headache, nausea, earaches, etc.) and be provided basic first aid in the case of minor injuries (scratches, etc.).
9. We understand that the University of Montevallo, MMC, staff, and other participants are not responsible for lost, stolen, or damaged personal property.
10. We understand that MMC drop-off time is 8:00-8:30AM and pick-up time is 5:00PM at the Davis Music Building. We understand that our commuter/day camp participant will not be supervised before 8:00AM and after 5:30PM.
11. We give consent for the camp participant's inclusion in television, audio, and video recordings, and to be photographed without compensation for use in University of Montevallo and MMC publications, promotional materials, and event recordings.
12. We consent for the camp participant to voluntarily and anonymously complete written questionnaires, surveys, and assessments for the purposes of research studies or to provide feedback on the MMC experience.
